Data Validation of Trial Conversion

Cegedim Healthcare Solutions make every endeavour to convert the data from your existing clinical system to the Cegedim Primary Care Solution preserving consistency of the data, and is wholly reliant on the quality of the data currently stored.

The trial data conversion is used by Cegedim Healthcare Solutions to assess timescales required for extracting the data from your existing system, including all attachment data, data validation and conversion to the Cegedim Primary Care Solution using proprietary Data Services conversion programs.

The trial data converted to the Cegedim Primary Care Solution is made available to the practice for evaluation of the quality and quantity of the data migrated. Primary care clinical systems are able to be customised in such a way that the use and subsequent storage of data can vary from practice to practice even where using the same system.
