

Introduction - Electronic Frailty Index (eFI)

We are pleased to announce the introduction of the **Vision+ Electronic Frailty Index** (eFI) Calculator and Stratification tool. The calculator helps identify and grade a patient's frailty level as well as assist in managing patients with frailty. The score is used to predict if a patient is at greater risk of admission or mortality. The eFI Stratification tool enables you to review and, where appropriate, record the eFI score for eligible patients.

How does the Electronic Frailty Index Calculator work?

The calculator consists of 36 deficits adding up to a score of 1. The deficits are based on Read codes or Read codes with values. A frailty score is derived by dividing the number of deficits present by the total possible. For example, if a patient has 9 out of 36 deficits, the eFI score is 0.25.

The 36 deficits consist of:

- Symptoms/Abnormal lab values and disability (eg dizziness, memory and cognitive values, visual impairment)
- Disease deficits (eg Respiratory Disease, Arthritis, Hypertension)

Note - Frailty is classified using the following criteria: Fit is equal to or under 0-12, Mild between 0.13 and <= 0.24. Moderate between 0.25 <= 0.36 and Severe is 0.36 or over.

Training Tip - The calculator is based on Read codes, so if you receive a letter from Accident and Emergency stating that a patient has had a fall and the fall is not recorded correctly, the patient may have an underestimated frailty score.

GMS Contract 2017/18 - England

From 1 July 2017, practices in England should use the **Vision+ Electronic Frailty Index** tools to identify patients aged 65 and over who are living with moderate and severe frailty. For those patients identified as living with severe frailty, and where clinically appropriate you need to:

- Medication review Conduct an annual medication review
- **Falls** Discuss whether the patient has fallen in the last 12 months and provide any other clinically relevant interventions
- **Summary Care Record (SCR)** Where a patient does not already have an enriched SCR, you should seek consent from the patient to activate the enhanced SCR. See *Summary Care Record England* http://help.visionhealth.co.uk/DLM520/Consultation_Manager/index.htm#2 5891

You are required to Read code the above interventions so that data can be collected on the following:

- Patients with a diagnosis of moderate frailty Read code 2Jd1 Moderate frailty
- Patients with severe frailty Read code **2Jd2 Severe frailty** who have:
 - An annual medication review
 - A fall in the preceding twelve months
 - Provided explicit consent to activate their enriched SCR

Note - The data is not used for performance management purposes. It is being collected to assist in collating prevalence figures.



Prerequisites

The eFI calculator, reports and templates are available to all practices. However, to assist with the GMS contract 2017/18, practices in England have extra lines within the eFI template. See *How to use the Electronic Frailty Index Template* (page 7).

How to use the Electronic Frailty Index (eFI) Calculator in Consultation Manager

To view and apply the **Electronic Frailty Index (eFI)** calculator to an individual patient:

- **1.** From Consultation Manager, select a patient and open a consultation.
- 2. Click the arrow key alongside the Vision+ icon
- 3. Select Calculators Other.

Key points about using the calculator:

• Adding Data - To add data to the calculator, select the relevant line and click the three dots (...).

Activity limitation 27/02/2017: Barthel index [7]

Viewing data - The latest record is displayed on the calculator. To view historical data click the red Previous entries icon. A blue Previous entry

icon indicates that the patient does not have any previous records.

- **Predicted/Data Entry Mode** Selecting Predicted enables you to do a '*What If* 'scenario to show the patient how changes in their health can affect their score. You can use the Predicted/Data Entry option to toggle between '*What If*' scenarios and recording actual data. - **OK and OK & Attach** To save the Read code, score and questionnaire select **OK & Attach**. To save just the Read code and score (without the questionnaire) click **OK**.

Reminder - You cannot select **OK** or **OK & Attach** whilst in Predicted mode.

• **eFI Score Read code** - Read code **38QI.00 FI - Frailty Index** is recorded in the patient's journal under Scoring Test Result.

Note - Practices in England must also record the eFI grading. See *GMS Contract 2017/18 - England* (page 2) or *How to use the eFI Template* (page 7).



How to view eFI Alerts

The alert popup window reviews a patient's record and assesses their frailty eligibility. Alerts also display if additional information is required.

To view alerts:

- **1.** From Consultation Manager, select the patient.
- 2. Select Show Other Indicators on the Vision+ floating toolbar



Note - By default QOF alerts display when you select a patient in Consultation Manager. To combine both QOF and non-QOF alerts eg eFI alerts - see *Combine triggers* http://help.visionhealth.co.uk/DLM520/Visionplus/index.htm#46582.

Alert Popup

- 4. From the alert window you can:
 - Double click on one of the expanded lines to launch the template where you can add the latest eFI score to the patient record (or right click and select Show Template)
 - Select Calculator from the toolbar

Key points about the alert prompts

- eFI score recorded, but grade not coded This warning indicates that the patient has an eFI score (Read code 38QI - Frailty Index) but the Read code required for the GMS contract is not recorded, for example:
 - Read code 2Jd0 Mild frailty
 - Read code 2Jd1 Moderate frailty
 - Read code 2Jd2 Severe frailty

- **Estimated frailty** Estimated frailty suggests no frailty or grading is recorded but the patient may be eligible.
- eFI Severity has Worsened This prompt displays if a patient's frailty has deteriorated since their last recorded score based on new Read codes recorded.

How to use the eFI Template

The eFI template is a simple to use screen that is designed to provide pertinent clinical information at a glance. It is interactive and only allows you to add information that is relevant to the patient.

For practices in England the template complies with GMS requirements and provides some extra data entry lines.

To select the eFI template in Consultation Manager:

1. From the Vision+ floating toolbar, select the arrow alongside the Vision+ icon



<u>2.</u> Now, select **Clinical Templates - eFI Severity Stratification**.

<u>3.</u> The eFI template screen displays. Below are some examples of how data is displayed:

The patient has a Frailty score recorded as **Moderate** but it has not been graded (as per the GMS contract in England). To record the grade click the green cross button.

1. Log into Vision, right click on **Vision+** and select **Practice Reports**.

2. Select Practice Lists.

3. Click eFI Severity Stratification.

<u>4.</u> The report is run and on completion displays categories of data making it easier to identify specific cohorts of patients.

Note - Reporting lines are only displayed where patients meet the relevant criteria, for this reason the screenshots below may not mirror your screen.

How to work with patient lists

To view patient information double click on the report line or click the expand 📩 icon. Highlight the patient's details and choose one of the following options from the toolbar or right click on the patient details.

Note - Any information recorded automatically updates the patient's record in Consultation Manager and where appropriate, removes the patient from the list or moves them to another reporting line.

eFI Reports

- **Preview, Print, CSV** Patients lists can be previewed, printed or exported as a CSV file.
- **Open Patient** This takes you directly into the patient's Consultation Manager record.
- **Electronic Frailty Index** The electronic Frailty Index calculator can be accessed directly from any reporting line that requires you to record a score. Where the score is already recorded and has not worsened this option is not available.
- **Codeset** The codeset option allows you to add the appropriate Read code or score to the patient's record.
- Show Template This option launches the eFI template screen. This is
 particularly useful for practices in England where you have to record
 additional information.

- **Show Indicators** This option invokes the eFI alert popup window without opening Consultation Manager.
- **Indicator Logic** This option allows you to see why the patient is on the cohort list.

How to apply the eFI Stratification Tool

Practices in England are required to identify patients over 65 with moderate or severe frailty. Some of the reporting lines in Vision+ Practice reports, categorise patients who have an estimated risk of moderate or severe frailty but who do not have a score recorded. Below describes how to add the score to an individual patient.



Applying the score to an individual patient

<u>1.</u> Highlight the line "No Frailty score recorded, Estimated as severe frailty" and click
 to expand.



- **<u>2.</u>** Highlight the patient and select **electronic Frailty Index** the Toolbar.
- **<u>3.</u>** From the calculator screen click **OK** or **OK & Attach** to record the score. See *How* to use the Electronic Frailty Index (eFI) Calculator in Consultation Manager (page 3).
- 4. To record the severity Read code (as part of the GMS contract), from the floating



5. Alternatively, if you have reviewed the patient you can do this on a patient by patient basis in Consultation Manager - See *How to use the eFI Template* (page 7).

How to send patient's a Letter/SMS text message

To send a group of patients a letter or text message you first need to create your letter or SMS template - See *Designing a letter template http://help.visionhealth.co.uk/DLM520/Visionplus/index.htm#46474* or *Creating an SMS message template http://help.visionhealth.co.uk/DLM520/Visionplus/index.htm#64935*.

Then, to run your mail/SMS merge for your eFI list of patients:

- **<u>1.</u>** From Vision+ **Practice Reports**.
- **2.** Highlight the report line and select **Merge Indicator**.
- **3.** Select the patient(s).
- 4. From the mailings screen either:
 - Choose the mail merge letter and select Mail, or
